GENEL GEREKÇE

Şırnak'ın Uludere İlçesinin Şenoba Beldesinin Kato Dağı'nda PKK'lı teröristlere yönelik başlatılan operasyonu sürdüren askerlerin bulunduğu helikopter düşmüştür. Helikopter faciasında operasyonları yöneten Tümgeneral Aydoğan Aydın ile 12 askerimiz şehit olmuştur. Tümgeneral Aydın ve askerlerin Beytüşebap'ta iftardan sonra Şenoba'ya döndüğü ve helikopterin Şenoba'dan yeniden havalandıktan 3 dakika sonra yüksek gerilim hattına takılarak düştüğü anlaşılmıştır.

Yıllardır terörle mücadele eden ülkemizde artık PKK terör örgütüne kurban edilecek bir tek cana bile tahammülümüz kalmamıştır. Ülkemizdeki yıllardır sivil vatandaşlarımızı ve emniyet güçlerimizi hedef alan toplu katliamlara neden olan terör saldırıları ile mücadele eden kahraman askerlerimizin şehit olması vatandaşımızı derin bir kedere boğmuştur. Yaşadığımız helikopter faciası sonucu Tümgeneral Aydoğan Aydın ile 12 askerimizin şehit olması ile toplumumuzda oluşan büyük üzüntüyü ve yaraları sarmak için toplumda “Ulusal Yas” beklentisi vardır. Bu gibi olaylara toplumumuzun devamlı duyarlı ve tedbirli olabilmesi için ülkece, hep birlikte kenetlenmek için “3 günlük ulusal yas” ilan edilmesi amaçlanmaktadır.
